We got buyin from our bank early on to manage via sep GL. Would have appreciated more time spent advising those who did not do that and more specifics for machine shop workforce, OT, etc.

In the beginning my impression was that you were just going to need to prove that you paid payroll and other expenses for the covered period and now it appears you have to draw the funds from the PPP money and not your operating account.
